TOURNAMENT RULES & REGULATIONS

1. This is a TBA Accredited Event. All games will be bowled in accordance with TBA Rules and Regulations.

2. This is a 2 Division (Scratch & Handicap) Event open to all TBA registered bowlers.

3.The handicap will be 100% of 230, Average must be 200 or less as at 31st of July 2024 to be able to enter Handicap Division.

4. This is a single-entry event. (No Rebuys)

5.Bowlers must wear acceptable attire. Jeans or Tracksuit pants are not considered acceptable attire.

6.Should a tie occur for 16th place in the Scratch division or 8th place in the Handicap Division after qualifying the highest last game will break the tie (highest handicap game in the handicap division), if a tie occurs for 8th place in the Scratch division after Stage 2 the highest last game will break the tie.

7.Smoking is not permitted during competition play.

8. Please remember before bowling in your first Q Tour South event of the year you must pay the \$25 Membership fee; You will need to specify if your membership is for the Scratch or Handicap division, please note the division you don't select, you will not receive any ranking points for that division. (\$4pp of the Scratch Division Membership Fee will go towards the Q Tour North vs Q Tour South Final Prize Fund)

9.Refund of Entry Fees – Should a refund of a players entry fee be required because of an event cancellation or approved refund by the tournament director, the full amount paid will be transferred to the players portal as a credit amount. The player then has two options either use the total credit amount for any other tournament that is using online entries or Request a Cashout of the total credit amount less the processing fee of 3%, please note no deposits will be refunded within 7 days of the event and no full refunds will be given within 48hrs before the commencement of the event.
