# COACH CLINIC

A COACHING CLINIC IS TO BE HELD FOR THE INCLUSION NATIONAL HIGH PERFORMANCE SQUAD. COST IS TO BE CONFIRMED WITH MORE DETAILS RELEASED AT A LATER DATE.





- 1. Open to all 2025 TBA registered bowlers who have a disability. TBA defines a bowler with a disability "as a person who suffers from a condition that has limitation, restriction or impairment that restricts everyday activity. The condition is permanent. It should be noted that degree or degrees of pain are not considered a disability.
- 2. If requested, to prove a disability, a bowler needs to provide one of the types of evidence listed in RULE 214 - Disability definition of, in the TBA League, Tournament & General Playing rules of, in the TBA League, Tournament & General Playing Rules.
- 3. Any bowler who is unsure of their eligibility to compete should apply to the Tournament Director for final ruling. Bowlers may be asked to provide written medical information. It is the bowlers responsibility to ensure evidence in support of their disability can be produced. Failure to produce acceptable evidence may result in disqualification with further participation in the tournament not permitted.
- 4. All games will be bowled in accordance with TBA rules and regulations.
- 5. TBA Inclusion ranking points will be allocated to bowlers who are silver members at least 24 hours prior to the tournament commencing (League/Junior + Silver Upgrade).

  6. TBA registration checks will be completed prior to the commencement of the event.
- 7. Entry Fee: \$280 via the TenpinResults portal a \$100 deposit is required at the time of entry nomination, with the balance to be paid by 17 October 2025.
- 8. Refund of Entry Fees Should a refund of a player's entry fee be required because of an event cancellation or approved refund by the tournament director, the full amount will be transferred to the player's portal as a credit amount. The player then has two options - 1. Use the total credit amount for any other tournament that is using online entries on TenpinResults. 2. Request a cash-out of the total credit amount less the processing fee (3%).
- 9. Dress code appropriate bowling attire to be worn dress shorts for men will be permitted. Jeans, tights, or track pants are not acceptable.
- 10. The Tournament Director and TBA reserve the right to check any bowler's equipment at any time. Any equipment to be found to breach TBA regulations will result in disqualification with no claim on any prize money.
- 11. Any bowler that fails to check in on Sunday 26 October 2025, will be replaced by the first available
- 12. Any matters not covered in these conditions will be decided by the Tournament Director whose decision will be final.
- 13. Smoking, consumption of alcohol and use of mobile phones while competing are not permitted.
- 14. Ties for qualification to stage 2 will be decided by a 1-game playoff. All other ties will be decided by highest pinfall game from qualifying.
- 15. Subsequent ties will be broken by 9th and 10th frame roll-off, and then if needed, golden ball until broken.
- 16. The Tournament Director will decide any matter not covered in these conditions
